Motion made by Alderman Schoppe to **table** a salary adjustment for the Police Department. **Seconded** to **table** by Alderman Orozco. Motion to **table** **carried** by a vote of 5 in favor and 0 opposed.

**SAVVY Citizens Notification System**

Motion made by Alderman Schoppe to **table** the SAVVY Citizen Notification System. **Seconded** to **table** by Alderman Orozco. Motion to **table** **carried** by a vote of 5 in favor and 0 opposed.
